GENERAL CONDITIONS

1. Competitive quotations shall be submitted in the form attached to these quotation documents in closed sealed cover.
2. The quotation should be addressed to the Managing Director, Kerala State Co-Operative Rubber Marketing Federation Ltd., P.B.No.15, Gandhinagar, KOCHI - 682 020, Kerala, in a sealed cover with the quotation No. with date and also the name of the party submitting the quotation superscribed on the cover.
3. Intending quotationers should send their quotations so as to reach the Managing Director on or before the date and time stipulated in the quotation. Quotations received after the specified date and time will not be accepted on any account.
- 4(a) Quotationer should send along with his quotation Earnest Money deposit as detailed for each item of materials quoted. The amount should be paid by Demand Draft in favour of The Kerala State Coop. Rubber Marketing Federation Ltd., payable at Kochi. Cheques will not be accepted. The earnest money deposit of the unsuccessful quotationers will be returned after the quotations are finalised but that of the successful quotationers will be adjusted towards interest free security deposit for the satisfactory performance of the contract.
- (b) Small Scale Industries and Cottage Industries and Industrial Cooperatives within the Kerala State which are certified as such by the Director of Industries and Commerce will be exempted from furnishing earnest money deposit in support of quotations submitted by them.
5. The quotations will be opened on the stipulated day and time at the office of the Managing Director, in the presence of such of those quotationers or their nominees who may be present at that time.
6. The price quoted should be firm till 31-3-2011 and if any quotationer withdraws from his quotation before 31-03-2011, the Earnest Money deposited by him will be forfeited to the Federation and such parties will be debarred from participating tender of the Federation in future.
7. Quotationers shall invariably specify in their quotation the delivery conditions including the time required for the supply of the articles quoted for.
8. The quotationers shall clearly specify whether the articles offered bear Indian Standard Institution Certification mark or not. In such cases they shall produce copies of certification mark along with their quotation in support of it.

9. The acceptance of the quotation rests entirely with Rubbermark who are not bound themselves to accept the lowest or any quotation. But the quotationers on their part should be prepared to carry out such portion of the supplies included in their quotations as may be allotted to them.
10. In the case of material of technical nature, the successful quotationer should be prepared to guarantee satisfactory performance for a definite period under a definite penalty.
11. Communication of acceptance of the quotation constitutes a concluded contract. Nevertheless the successful quotationer shall also execute an agreement for the due fulfillment of the contract within the period to be specified in the letter of acceptance.
Time is the essence of the contract.
12. In case the successful quotationer fails to make the supply of the entire quantity of the material or after having supplied part of the quantity, fails to fulfil the contract in full all or any of the materials not supplied may, at the discretion of the Managing Director, be purchased by means of another quotation or by negotiation or from the next higher quotationer and the resultant loss, if any, sustained to the Federation together with such amount as may be fixed by the Managing Director towards the cost of damages be realised from the defaulting quotationer. Even in the case where no alternative purchases are arranged for materials not supplied the security deposit of the quotationer shall be forfeited.
13. The security deposit shall subject to the condition specified herein, be returned to the contractor within three months after the expiry of the contract, but in the event of any disputes arising between Rubbermark and the quotationer, Rubbermark shall be entitled to deduct out of the deposits or the balance thereof, until such dispute is determined the amount of such damages, costs, charges and expenses as may be claimed.
14. All payments to the contractors will be made by Account payee cheques.
15. The quotationers shall quote also the percentage of rebate (discount) offered by them in case the payment is made promptly within fifteen days/within one month of taking delivery of the stores.

16. The contractor shall not assign, make over, or sublet the contract to any person or firm or corporate body without the consent of the Federation in writing.
17. The quotationer shall undertake to supply materials according to the standard sample and/or specification.
18. No representation for enhancement of rates accepted will be considered. However, in exceptional cases if Rubbermark is convinced of any compelling need for enhancement of rate, it may do so.
19. Quotationers should be prepared to accept orders for staggered delivery.
20. Sample should be forwarded along with the quotation.
21. If, any Quotationer submit, more than one quote for the same item all such quotations will be rejected and will not be considered.
22. Once the contract is awarded the quotationer shall perform the contract failing which the party shall reimburse all extra cost and expenses incurred by the Federation for procuring this materials under the contract.
23. The prices quoted should be inclusive of all taxes, duties, Cesses etc. which are or may become payable by the contractor from time to time under the present or future statutes during the contract period.
24. The quotationer will invariably furnish the following certificate with their bills for payment:

"Certified that the goods on which Sales tax has been charged have not been exempted under the Central Sales Tax Act and the State Sales Tax Act or the rules made there under and the charges on account of sales tax on these goods are correct under the provisions of the relevant Act or the rules made there under. Certified further _____ that we-----

25. Special conditions if any, of the quotationers attached with the quotations will not be applicable to the contract unless they are expressly accepted in writing by the purchaser.
26. In the event of any question or dispute arising under these conditions or in connection with this contract the same shall be referred to the Registrar of Cooperative Societies for adjudication as provided under the Kerala Cooperative Societies Act 1969.

27. The quotationer should send along with his quotation an agreement executed and signed in Kerala Stamp Paper of value Rs.50/- purchased in Kerala State. A specimen form of agreement is given as annexure to this tender. Quotations without the agreement in stamp paper will be rejected outright. But in deserving cases where agreement within a period of ten days from the date of issue of such intimation, if the purchasing officer is satisfied that the omission to forward the agreement along with the quotation was due to causes beyond the control of the quotationer and was not due to any negligence of his part. Agreement received from a quotationer after the above time limit will not be considered.
28. The quantity mentioned in the quotation is only approximate and the supplier will have to effect the supply as shown in the purchase order. The right to Purchase lesser or more quantity than the quoted quantity is reserved by Rubbermark.
29. Disputes arising during the contract period if any will be pursued in Ernakulam court of Judiciary only.
